# DISCLOSURE AND ACCOUNTING NOTES REGARDING DEBTORS' SCHEDULES OF ASSETS AND LIABILITIES AND STATEMENTS OF FINANCIAL AFFAIRS

On August 30, 2023 (the "<u>Petition Date</u>"), Benitago Inc. ("<u>Parent</u>") and its debtor affiliates, as debtors and debtors in possession (each a "<u>Debtor</u>," collectively, the "<u>Debtors</u>," and together with their non-debtor affiliates, the "<u>Company</u>"), commenced voluntary cases (the "<u>Chapter 11 Cases</u>") under chapter 11 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>") in the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court").

The Debtors continue to operate their businesses and manage their properties as debtors and debtors in possession, pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. The Chapter 11 Cases have been consolidated for procedural purposes only and are being jointly administered under case number 23-10738 (JPM).

The Schedules of Assets and Liabilities (the "Schedules") and Statements of Financial Affairs (the "Statements" or "SOFAs") were prepared pursuant to Bankruptcy Code section 521 and Rule 1007 of the Federal Rules of Bankruptcy Procedure by the Debtors' management using unaudited information available as of the Petition Date.

These Disclosure and Accounting Notes Regarding the Debtors' Schedules of Assets and Liabilities and Statements of Financial Affairs (these "Disclosure and Accounting Notes") are incorporated by reference in, and comprise an integral part of, each of the Debtors' Schedules, sub-Schedules, Statements, sub-Statements, exhibits, and continuation sheets, and should be referred to in connection with any review of the Schedules and Statements. Disclosure of information in one Schedule, sub-Schedule, Statement, sub-Statement, exhibit, or continuation sheet, even if incorrectly placed, shall be deemed to be disclosed in the correct Schedule, Statement, exhibit, or continuation sheet.

The Debtors in these chapter 11 cases, along with the last four digits of each Debtor's tax identification number, are: Benitago, Inc. (4084); Acrux LLC (9391); Aludra Limited (4147); Algedi LLC (3835); Biham LLC (4095); Canopus LLC (8124); Denebola LLC (5430); Errai LLC (7652); Felis LLC (4176); Ginan LLC (2439); Hamal LLC (1775); Izar LLC (6010); Jabbah LLC (0658); Kamuy LLC (8461); Lich LLC (2892); Maasym LLC (9332); Nusakan LLC (1861); Okab LLC (6499); Phact LLC (3663); Chechia LLC (N/A); Dalim LLC (4741); Segin LLC (8849); Taiyi LLC (N/A); Veritate LLC (6416); Wazn LLC (7193); Yildun LLC (3017); Bharani LLC (1732); Alhena LLC (7613); and Revati LLC (0170). The location of the Debtors' service address for purposes of these chapter 11 cases is: 1 Liberty Street, Ste. 320, New York, New York 10006.

1. <u>Basis of Presentation</u>. The Company historically prepared consolidated unaudited monthly financial statements, which included all of the Debtors and affiliated non-Debtor entities. Unlike the consolidated financial statements, the Schedules and Statements generally reflect the assets and liabilities of each Debtor on a non-consolidated basis. Accordingly, the amounts listed in the Schedules and Statements will likely differ, at times materially, from the consolidated financial reports prepared historically by the Company.

Although the Schedules and Statements may, at times, incorporate information prepared in accordance with United States generally accepted accounting principles ("GAAP"), the Schedules and Statements neither purport to represent nor reconcile to financial statements otherwise prepared and/or distributed by the Debtors in accordance with GAAP or otherwise.

- **2.** <u>Defined Terms</u>. Additional information regarding the Debtors, including their business operations, their corporate and capital structure, and the events leading to the commencement of the Chapter 11 Cases is set forth in the *Declaration of Santiago Nestares Lampo Pursuant to Local Bankruptcy Rule 1007-2 and in Support of the Debtors' Chapter 11 Petitions* [Docket No. 12] and the *Declaration of Thomas Studebaker, the Debtors' Chief Restructuring Officer, Pursuant to Local Bankruptcy Rule 1007-2 and in Support of the Debtors' Chapter 11 Petitions and First Day Pleadings* [Docket No. 13] (together, the "<u>First Day Declarations</u>") [Docket No. 38]. Capitalized terms used but not defined herein have the meanings ascribed to them in the First Day Declarations.
- **Reporting Date**. Each Debtor operates on a fiscal year ending on December 31 annually. All asset and liability information, except where otherwise noted, is provided as of August 31, 2023.
- **Currency**. All amounts are reflected in U.S. dollars, which the Company uses as its reporting currency. Unless otherwise noted, the Debtors used conversion rates provided by Federal Reserve Bank of the United States as of the Petition Date. One significant exception is the value of prepetition transfers, which were valued using the conversion rates as of the date of such transfer.
- 5. <u>Undetermined, To be Determined or Unknown Amounts</u>. The description of an amount as "undetermined," "to be determined," or "unknown" is not intended to reflect upon the materiality of such amount. Certain amounts may be clarified during the course of the Chapter 11 Case.
- **6.** <u>Totals</u>. All totals included in the Schedules and Statements represent totals of all known amounts. To the extent there are unknown or undetermined values, these will not be listed in the totals.
- 7. <u>Asset Presentation and Valuation</u>. The Debtors' assets are presented at values consistent with their books and records. These values do not purport to represent the ultimate value that would be received in the event of a sale and may not represent economic value as determined by an appraisal or other valuation technique. Unless otherwise noted, the carrying value of the Debtors' assets as reported on their books (*i.e.*, net book value), rather than their current economic value, is reflected on the Schedules and Statements.

8. <u>Intercompany Transactions.</u> Net intercompany balances between a given Debtor and other Company entities are reported on such Debtor's Schedules in response to Question AB77 (Other property of any kind not already listed) for net intercompany receivables and Question F for any net intercompany payables. The net intercompany balances are as of August 31, 2023. The intercompany claims listed in Question AB77 and Question F reflect only those intercompany payments and obligations that were recorded in the Company's books and records in the ordinary course on a prepetition basis, based on the sale of inventory at cost and allocation of costs. There may exist additional intercompany claims that the Debtors' books and records did not record on a prepetition basis that may be asserted in the course of the Chapter 11 Cases.

Prepetition in the ordinary course of business, Parent sold inventory at cost to the Acrux Subsidiaries and incurred obligations on their behalf. Following the sale of the inventory by the Acrux Subsidiary to a third party, the Acrux Subsidiary would transfer the sale proceeds to Acrux, which would aggregate and transfer funds to Parent. For the purposes of these Schedules and Statements, amounts owed by an Acrux Subsidiary to Parent were deemed satisfied only when Acrux transferred the sales proceeds to Parent. To the extent an Acrux Subsidiary's transferred sale proceeds were less than the amount owed to Parent by such Acrux Subsidiary as of the Petition Date, a liability owed by that Acrux Subsidiary to Parent has been reported. Additionally, on August 23, 2023, Acrux and its subsidiaries entered into an Interim Sales and Services Agreement with Parent. Because the sales proceeds transferred from Acrux to Parent were less than the aggregate amount owed under this agreement as of the Petition Date, a liability owed by Acrux to Parent has been reported.

- **9.** First Day Orders. The Bankruptcy Court has entered orders (each, a "First Day Order") authorizing the Debtors to pay, in whole or in part, various outstanding prepetition claims, including but not limited to, certain claims relating to the Debtors' employees' wages and compensation (not exceeding the \$15,150 cap under sections 507(a)(4) and 507(a)(5) of the Bankruptcy Code per employee); critical and foreign vendors, warehouse and shipping lien holders, and 503(b)(9) claimants; and pre-petition taxes and fees. Given that certain of these claims have been paid or are anticipated to be paid in accordance with the First Day Orders, such claims may not be listed on Schedule E/F, notwithstanding that such claims existed as of the Petition Date, or may otherwise be listed as "unknown" or "to be determined."
- 10. <u>Intellectual Property Rights</u>. Exclusion of certain intellectual property shall not be construed to be an admission that such intellectual property rights have been abandoned, have been terminated, or otherwise have expired by their terms, or have been assigned or otherwise transferred pursuant to a sale, acquisition, or other transaction. Conversely, inclusion of certain intellectual property shall not be construed to be an admission that such intellectual property rights have not been abandoned, have not been terminated, or otherwise have not expired by their terms, or have not been assigned or otherwise transferred pursuant to a sale, acquisition, or other transaction. The Debtors have made every effort to attribute intellectual property to the rightful Debtor owner; however, in some instances, intellectual property owned by one Debtor may, in fact, be owned by another. Accordingly, the Debtors reserve all of their rights with respect to the legal status of any and all intellectual property rights.

11. <u>Liens</u>. The inclusion on Schedule D of creditors is not an acknowledgement of the validity, extent, or priority of any liens, and the Debtors reserve their right to challenge such liens and the underlying claims on any ground whatsoever. A careful review of the applicable agreements and other relevant documents is necessary for a complete description of the collateral and the nature, extent and priority of any liens. Nothing in these Disclosure and Accounting Notes or the Schedules and Statements shall be deemed a modification or interpretation of the terms of such agreements or an acknowledgment of same. Certain liens may have been inadvertently marked as disputed but had previously been acknowledged in an order of the Court as not being disputed by the Debtors. It is not the Debtors' intent that the Schedules be construed to supersede any orders entered by the Bankruptcy Court.

#### **Schedules of Assets and Liabilities**

#### **Schedule A/B Notes.**

- General. Each Debtor's assets in Schedule A/B are listed at net book value as of the Petition Date, unless otherwise noted, and may not necessarily reflect the market or recoverable value of these assets as of the Petition Date. Assets that are fully depreciated are not listed on Schedule A/B. Assets and liabilities are recorded when known.
- Schedule A/B, Part 1 Cash and Cash Equivalents. The reported bank balances (including investments and overnight accounts) and cash on hand include cash held in various currencies, converted into U.S. dollars.
- Schedule A/B, Part 4 Investments; Non-Publicly Traded Stock and Interests in Incorporated and Unincorporated Businesses, including any Interest in an LLC, Partnership, or Joint Venture. Ownership interests in subsidiaries, partnerships, joint ventures, and investments in non-publicly traded securities have been listed in Schedule A/B, Part 4 in undetermined amounts because the fair market value of such ownership is dependent on numerous variables and factors and may differ significantly from their net book value.
- Schedule A/B, Part 5 Inventory, excluding agricultural assets, Items 24-25. The Debtors' perishable inventory reflected in Item 24 include supplements, health products, skincare products, other products with expiry dates. Among the First Day Orders, the Debtors obtained authority to pay claims of vendors who delivered goods to the Debtors that were received within the 20-day period immediately preceding the Petition Date.
- Schedule A/B, Part 10 Intangibles and Intellectual Property, Items 59-66. The Debtors report all intellectual property assets with an undetermined current value. The net book value for the "Goodwill" listed in response to Item 65 reflects the book value of certain investment assets acquired by a Debtor, excluding the value of physical inventory acquired as part of the investment. On a balance sheet basis, the value of such "Goodwill" encompasses all intangible value and intellectual property of the investment asset.

#### Schedule D Notes.

- Except as specifically stated herein, lessors of real property and equipment, utility companies, and any other parties which may hold security deposits or other security interests, have not been listed on Schedule D. The Debtors have also not listed on Schedule D any parties whose claims may be secured through rights of setoff, deposits, advance payments or inchoate statutory lien rights.
- The amounts outstanding under the CoVenture secured debt reflect the approximate principal and interest amounts as of the Petition Date. The amounts outstanding under the SellersFunding secured debt reflect the approximate principal amounts only as of the Petition Date.
- The descriptions provided on Schedule D, including the descriptions of the underlying collateral, are intended only as a summary.

#### Schedule E/F Notes.

- The claims listed on Schedule E/F arose or were incurred on various dates. In certain instances, the date on which a claim arose may be unknown or subject to dispute. Although reasonable efforts have been made to determine the dates upon which such claims were incurred or arose, the exact fixing of each such date would be unduly burdensome and cost-prohibitive. Consequently, the Debtors have not listed a date for all claims set forth on Schedule E/F.
- Amounts for the Debtors' trade claims set forth on Schedule E/F reflect the payables owed as of the Petition Date based on the Debtors' books and records as of the filing of these Schedules. Amounts paid under the First Day Orders have been deducted from the Petition Date trade accounts payable.
- All litigation-related claims referenced in Schedule E/F are contingent, unliquidated, and disputed, unless otherwise indicated.

#### Schedule G Notes.

- The placing of a contract or lease onto Schedule G shall not be deemed an admission that such contract is an executory contract or unexpired lease, or that it is necessarily a binding, valid, and enforceable contract. Likewise, omission of a contract or agreement from Schedule G does not constitute an admission that such omitted contract or agreement is not an executory contract or unexpired lease.
- In some cases, the same contract counterparty appears multiple times in a Debtor's Schedule G. This multiple listing is generally intended to reflect distinct agreements between the applicable Debtor and such counterparty, however, due to the magnitude of data, it is possible that a multiple listing may be the result of duplicates.

- Certain confidentiality, non-disclosure, and non-compete agreements may not be listed on Schedule G. Additionally, certain non-exclusive "finder's fee" agreements may not be listed.
- Certain of the contracts and agreements listed on Schedule G may consist of several parts, including purchase orders, amendments, restatements, waivers, letters and other documents that may not be listed on Schedule G or that may be listed as a single entry. The Debtors expressly reserve their rights to challenge whether such related materials constitute an executory contract, a single contract or agreement, or multiple, severable or separate contracts.
- Certain of the contracts, agreements, and leases listed on Schedule G may have been entered into by more than one of the Debtors. Further, in certain instances, the specific Debtor obligor to certain of the executory contracts could not be specifically ascertained. In such cases, the Debtors have made their best efforts to determine the correct Debtor's Schedule G on which to list such executory contract.

#### **Statement of Financial Affairs**

<u>Statement Question 1 and 2 – Revenue</u>. The net sales for the 2023 stub period are as of August 31, 2023.

<u>Statement Question 3 – 90 Day Payments</u>. Payments to insiders within the 90 days prior to the Petition Date listed in response to SOFA 4 are not also listed in response to SOFA 3. SOFA 3 excludes regular payments for compensation made to employees and independent contractors.

<u>Statement Question 4 – Payments to Insiders.</u> SOFA 4 includes only those payments made to insiders on behalf of the respective Debtor during the one year preceding the Petition Date. For the purposes of SOFA 4, the Debtors deemed "insiders" to include all directors, officers, equity owners, and managers of a Debtor, and any relatives thereof.

<u>Statement Question 7 – Legal Actions</u>. The Debtors have not included workers' compensation claims in response to this question because the Debtors maintain that this disclosure would be in violation of certain laws including HIPAA (Health Insurance Portability and Accountability Act of 1996).

<u>Statement Question 9 - Certain Gifts and Charitable Contributions</u>. In the ordinary course of business, the Company on occasion provided gifts, such as iPads, as part of promotions to customers and clients for business development purposes. It is possible that the aggregate value of such gifts may have exceeded \$1,000 for certain individuals, however the Company does not maintain sufficient records to determine if this occurred.

<u>Statement Question 10 - Certain Losses</u>. The Debtors did not include losses covered by insurance or losses for which the Debtors were reimbursed in their responses to Statement Question 10.

<u>Statement Question 16 – Personally Identifiable Information</u>. Certain customer information may be collected by Amazon and/or other marketplace operators, which the Company may have access to, subject to the information policies of Amazon or such marketplace operator. However, the Company generally does not retain the Personally Identifiable Information of its customers.

<u>Statement Question 21 – Property Held for Another.</u> In the ordinary course of business, an Acrux Subsidiary Debtor will at times be in control of certain inventory held by Amazon pursuant to an Amazon Account controlled by the Acrux Subsidiary, notwithstanding that Parent is the owner of such inventory. These situations are not included in the Debtors' responses to Statement Question 21.

<u>Statement Questions 28 and 29 – Directors and Officers</u>. For purposes of SOFA 28, each Debtor listed the names of all of its current officers and directors. For purposes of SOFA 29, each Debtor listed the names of all of its former officers and directors that it employed within the one year prior to the Petition Date.

<u>Statement Question 30 – Payments, Distributions, or Withdrawals to Insiders.</u> Refer to SOFA 4 for this item.
